 PLEASE USE THIS LETTER AS YOU LIKE BUT BE VERY AWARE THAT I WOULD LIKE TO REMAIN
ANONYMOUS.

I WOULD LIKE TO HAVE IT PUT ON RECORD THAT I AM FURIOUS THAT ANY MEDICAL PERSON CAN FORCE ANOTHER HUMAN BEING ONTO **MODERN DAY SHIT MEDICATION** AGAINST THEIR WILL WHEN THAT MEDICATION DOES **NOTHING** FOR THEM OTHER THAN DESTROY THEIR HEALTH FURTHER.

I HAD TOP HEALTH INSURANCE COVER. WHAT [REDACTED] HOSPITAL GAVE ME IN RETURN WAS CRIMINAL NEGLIGENCE - JUST PUTTING ME TO SLEEP FOR FOUR YEARS WITH ANTI-PSYCHOTIC MEDICATION **AND** AN OLD TYPE OF ANTI-DEPRESSANT - UNTIL I HAD THE STRENGTH AFTER FOUR YEARS OF HELL TO SAY THAT I WAS GETTING LEGAL HELP AGAINST THEM.

I WAS 43. MY INSTABILITY COULD HAVE BEEN CAUSED BY HORMONAL ISSUES. NO TESTS WERE DONE FOR THIS AND, EVEN IF THEY WERE, ONLY MEDICATION WOULD HAVE BEEN FORCED ON ME WITHOUT FIRST:

- * CONSULTATION WITH A MENTAL HEALTH PRACTITIONER OF MY CHOICE & BEING WARNED OF WHAT THE SIDE EFFECTS OF THE FORCED MEDICATION WOULD BE

MODERN MEDICATION, ESPECIALLY IN A POOR AREA LIKE [REDACTED] IS PUTRID AND SHOULD BE AN ABSOLUTE LAST RESORT.

THE DOCTORS AT THE MENTAL HEALTH WARDS AT [REDACTED] HOSPITAL AND [REDACTED] CONTINUING CARE WERE LOW LIFE SCUM. THEY JUST PUT YOU IN SOME QUEUE AND JUST ADMINISTER MEDICATION WITHOUT KNOWING WHAT THE CIRCUMSTANCES OF YOUR LIFE ARE OR MEDICAL HISTORY. I AM POSITIVE THAT I WAS WRONGLY DIAGNOSED AS HAVING **TWO**

SIMULTANEOUS DIFFERENT MENTAL HEALTH CONDITIONS:-
 BI-POLAR DISORDER
 SCHIZROID PERSONALITY DISORDER

A PSYCHIATRISTS I HAD SEEN SINCE MY TWENTIES TOLD ME THAT I HAD NO PERSONALITY DISORDER, AND SO DID ONE OF THE MANY PSYCHIATRISTS AT [REDACTED] CONTINUING CARE (SEE BELOW).

IN AMERICA, THERE ARE X-RAY MACHINES WHICH DETECT BI-POLAR DISORDER FOR SURE. AT [REDACTED] HOSPITAL, I WAS EXPOSED TO UNNECESSARY EXCESS RADIATION BY HAVING A GENERAL CT SCAN FOR MY BRAIN WHICH REVEALED NOTHING.

AT [REDACTED] CONTINUING CARE, WHERE I WAS FORCED TO ATTEND FOR A YEAR, I HAD AT LEAST **FIVE** DIFFERENT PSYCHIATRISTS RANDOMLY TURN UP TO SEE ME AT MY APPOINTMENTS THERE THROUGHOUT THAT TIME. AND **NO-ONE** THERE KNEW WHAT THE CORE OF MY PROBLEMS WERE. ON ONE OCCASION, A DOCTOR, DR. [REDACTED] TURNED UP WITHOUT MY FILE, SOMEONE I HAD NEVER MET BEFORE. SUCH A LUDICROUS EXAMPLE OF WHAT IT WAS

LIKE. PEOPLE THERE BEING PAID AS HEALTH PROFESSIONALS BUT JUST ADDING TO THE ABSOLUTE MISERY I WAS EXPERIENCING.

MY MESSAGE TO THE GOVERNMENT IS THIS:

IF YOU CAN'T AFFORD TO LOOK AFTER THE MENTALLY-ILL IN A THOROUGH ENOUGH WAY, EVEN WHEN THEY HAVE TOP HEALTH INSURANCE COVER -

DON'T BE CRIMINALS AND FORCE YOUR POISON INTO THEM AGAINST THEIR WILL.
