The Attorney-General has asked me to reply to you on his behalf. I am very sorry to hear about your difficulties. The Attorney-General and the Attorney-General's Department are unable to provide legal advice to individual members of the community. You suggest in your letter that you have previously contacted the Human Rights and Equal Opportunity Commission (now known as the Australian Human Rights Commission) and that it is unable to help you with your case. While the Australian Human Rights Commission is the independent national statutory body responsible for administering the Disability Discrimination Act 1992, it retains the discretion to choose not to pursue the cases KELUIN WAS THREATENED, HELD, N SEARCHED that are brought to its attention. If you have concerns you wish to raise about how the Commission handled your matter, or you are dissatisfied with the manner in which your complaint was handled, you may wish to raise these concerns directly with the President of the Commission, AM. Dear Sir,

RE: INCIDENT AT STREET CENT

We act for Mr. and Mrs. Dedlefs, who have instructed us in relation to their son Kelvin who works at the above centre.

We are instructed that on 1 October 2009 a memo was circulated by workers stating that there had recently been thefts from the female locker rooms and if there was another occurrence of theft "the police will be called and no one will be allowed to leave the building". On 5 October 2009 at 3.00pm a member of the support staff, namely informed workers that there had been another theft and no workers would be allowed to leave the centre until the thief was exposed and their bags would be searched. Workers were also threatened that the Police would be called. We have been further instructed that Kelvin felt very intimidated and scared and believed that he was not able to leave the centre. In fact, with his limited understanding, he believed that he was under arrest.

Our client sent you a letter on 6 October 2009 detailing his grievances with the actions taken by support staff on 5 October 2009. We have been provided with a copy of your reply dated 8 October 2009 and are instructed to respond as follows:
